Resolution Reimbursement to Syntero:

RESOLUTION AUTHORIZING AND DIRECTING REIMBURSEMENT TO SYNTERO, INCORPORATED IN SUPPORT OF COMMUNITY SERVICES

WHEREAS, Syntero, Incorporated is an advocate and supports the health and well-being of individuals, families and communities by providing professional, compassionate behavioral health and social services that adapt to the changing needs of the community.

WHEREAS, Washington Township also supports the services offered by Syntero, Incorporated and all that they do for the community.

WHEREAS, over the years, the Township has provided financial support to Syntero, Incorporated in the amount of \$50,000, or \$1.00 per Washington Township Resident (estimated population of 50,223).

WHEREAS, if there is a special funding need for a new program offered by Syntero, Incorporated in the future and there is a need for additional funding, Syntero, Incorporated can then request additional funding from the Township.

NOW, THEREFORE, BE IT RESOLVED, BY THE BOARD OF TOWNSHIP TRUSTEES OF WASHINGTON TOWNSHIP, FRANKLIN, DELAWARE, AND UNION COUNTIES, OHIO THAT:

- Section 1. The Board of Trustees of Washington Township hereby authorizes and directs the Fiscal Officer to reimburse Syntero, Incorporated an amount not to exceed \$50,000 to support the above causes as stated.
- Section 2. Resolution Amending the Charges:

Mr. Kranstuber introduced and moved the adoption of the following Resolution:

A RESOLUTION AMENDING THE CHARGES FOR THE USE OF AMBULANCE SERVICES AND EMERGENCY MEDICAL SERVICES

WHEREAS, Washington Township, through the Washington Township Fire Department, has been, and intends to continue, providing ambulance and emergency medical services; and

WHEREAS, R.C. 505.84 authorizes a Township to establish reasonable charges for the use of fire and rescue services, ambulance services, or emergency medical services. R.C. 505.84 also permits a Township to establish different charges for Township residents and nonresidents, and may, in its discretion, waive all or part of the charge for any resident; and

WHEREAS, at its September 27, 2016 meeting and after much thought and careful consideration, the Board of Trustees of Washington Township determined it was in the best interest of the Township to establish a use charge for ambulance and emergency medical services provided by the Washington Township Fire Department; and

WHEREAS, the charges established by that September 27, 2016 resolution were increased on January 29, 2019; and

WHEREAS, Washington Township recently learned The Center for Medicare Medicaid Services released The Ambulance Inflation Factor (AIF) for CY2022. This AIF contains a 8.7% rate increase for EMS services in 2022, a 5.1% increase in 2021 and a 0.2% increase in 2020; and

WHEREAS, while Washington Township is not limited to only a 14.48% increase, the Board of Trustees wants to increase its charges for these services by only 14.48%.

NOW, **THEREFORE, BE IT RESOLVED** by the Board of Trustees of Washington Township, Franklin, Delaware, and Union Counties, State of Ohio:

Section 1: Pursuant to R.C. 505.84, the following amended charges for the use of ambulance services and/or emergency medical services are hereby created and established for all persons (township resident or non-resident):

a. Basic Life Support (BLS): \$802.18
b. Advanced Life Support 1 (ALS1) \$948.24
c. Advanced Life Support 2 (ALS2) \$1,375.99
d. Loaded Mileage \$16.99

Section 2: The amended charges set forth in Section 1 shall take effect May 1, 2023.

Section 3: All other Sections and Sub-Sections of the Resolution for EMS Billing, adopted on September 27, 2016 shall remain unchanged, in effect, and enforceable.

Section 4: It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of the Board and that all deliberations of the Board and any of the decision making bodies of the Board of Trustees which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Motion to Approve Agreement:

Motion to Authorize the Purchase of Turnout Gear:

In accordance with the department's turnout gear purchasing model, at this time there are four full-time Firefighters that are fitted and due for new turnout gear in 2023. The vendor and turnout gear specifications remain the same as those utilized in 2022. Along with the fifteen-turnout gear sets purchased in January, this will bring the total sets purchased in 2023 up to nineteen. Each set of turnout gear is \$3,400 for a total of \$13,600. By continuing to purchase turnout gear at the rate identified in the Fire PPE program and budget process, all current full-time members should have a backup set of turnout gear in 2024.
