Minutes of September 26, 2023

Record of Proceedings

The Washington Township Board of Trustees regularly scheduled meeting held at the Washington Township Administration Building, 6200 Eiterman Road, Dublin, Ohio, on September 26, 2023, at 6:00 p.m., with Mr. Charles Kranstuber, Chairman, calling the meeting to order, and it opened with the Pledge of Allegiance.

Sheriff's Report:

Deputy Burton Haren was present and submitted written report for the Trustees to review and a discussion held.

Append #001

Rings Road Roundabout:

Mr. Matt Rehfus from the Franklin County Engineer's Office was present to discuss preliminary designs and timeline for the Rings/Cosgray Roads intersection improvements. Mr. Joe Weithman with Mull and Weithman Architects was attending via cell phone, to discuss their review of the proposed roundabouts, and the impact the roundabouts will have on Washington Township's possible future Fire Station land.

FCEO is working collaboratively with the City of Dublin and the Township to identify future improvements to enhance safety and mobility at this increasingly traveled and dangerous intersection.

The different designs were presented to the Board of Trustees for their reviewed and a discussion was held but no action was taken at this time.

457 Plan Record Keeper Change:

Mr. Drew Boyer of Boyer Financial Group, one of the Township deferred compensation plan administrators was present. Mr. Boyer works with Township employees throughout their career at WT and through their retiring process. During one of his consultations, it was discovered that our current 457 Plan Record Keeper, T. Rowe Price, has internal system limitations that prevents employees from maximizing the Federal IRS contribution limits to a deferred compensation plan. T. Rowe Price is unwilling to fix their internal system and Mr. Boyer believes the best decision for our employees is to switch record keeper for our Traditional and Roth 457 Plans. Mr. Boyer suggests moving to Empower Annuity Insurance Company of America, the largest record keeper nationwide for deferred compensation plans.

Resolution Approving Change in Township's 457 Plan Record Keeper:

Mr. Kranstuber introduced and moved the adoption of the following Resolution:

A RESOLUTION APPROVING A CHANGE IN THE TOWNSHIP'S 457 PLAN RECORD KEEPER AND CUSTODIAN TO EMPOWER ANNUITY INSURANCE COMPANY OF AMERICA; AND AUTHORIZING THE TOWNSHIP ADMINISTRATOR TO EXECUTE ALL DOCUMENTS NECESSARY TO MAKE THIS CHANGE

WHEREAS, in technical terms, a 457 plan is a defined contribution plan for governmental employees that is governed under Section 457(b) of the Internal Revenue Code and commonly known as a governmental deferred compensation plan;

WHEREAS, under a 457 plan, public employees contribute pre-tax money each payday into a custodial trust account set up for them by the 457(b) plan, and invest that money, so that it can grow tax-deferred;

WHEREAS, in order to show compliance with the IRS, a 457 Plan must have a plan record keeper, who serves as the plan's accountant and monitors/maintains records of payroll deferrals, rollovers, and distributions;

WHEREAS, in order to show compliance with the IRS, a 457 Plan must have a custodian who holds the accounts assets;

WHEREAS, Boyer Financial Group currently serves as one of Washington Township's 457 Plan administrators;

WHEREAS, T.Rowe Price currently serves as one of Washington Township's 457 Plan record keepers and custodians;

WHEREAS, in September 2023, T.Rowe Price notified Boyer Financial Group of their internal system limitation of deferring only \$22,500, whereas the Federal limit is \$45,000;

WHEREAS, the Board of Trustees of Washington Township desires to allow employees to defer compensation to the federal maximum if they so choose;

WHEREAS, Empower Insurance Company of America is the largest deferred compensation provider nationwide and is capable of serving as one of Washington Township's 457 Plan records keeper and custodian.

NOW, **THEREFORE, BE IT RESOLVED** by the Board of Trustees of Washington Township, Franklin, Delaware, and Union Counties, State of Ohio:

Section 1: The Board of Trustees hereby approves changing Washington Township's 457 Plan Record Keeper to Empower Insurance Company of America.

Section 2: The Board of Trustees hereby approves changing Washington Township's 457 Plan Custodian to Empower Insurance Company of America.

Section 3. The Board of Trustees hereby authorizes and directs the Township Administrator to execute all documents necessary to change Washington Township's 457 Plan Record Keeper and Custodian to Empower Insurance Company of America.

WHEREAS, it is currently recognized that control of stormwater quantity and quality is most effectively implemented when people and organizations understand the related causes and consequences of polluted stormwater runoff and flooding, and the actions they can take to control these; and

WHEREAS, the development and implementation of effective, outcomes-based stormwater education and outreach programs will meet the related federal stormwater pollution control requirements and those of the communities they serve so that Ohio continues to be a great place to live, work and play.
